Minutes of the Planning, Infrastructure and Highways Committee Meeting held on the Monday, 2nd November 2020, 7:30pm, Zoom Meeting

To consider any matters arising from the minutes of the meeting of the 10th September 2020 not considered elsewhere on the agenda.

a) Request for visits to speak to the Committee:

i) Staffordshire County Council Highways

This meeting is still to be arranged.

ii) Air Quality – Environmental Officer

This meeting has not yet been arranged.

b) Update on Woodside Cottages – poor state of road/footpath 114.

The Clerk updated the Committee. Severn Trent have agreed to pay half of the costs instead of the residents. It was agreed that the residents should sign a disclaimer which states that it is understood that the Town Council is not taking on any responsibility for future liability or maintenance. Cllr P Waring suggested that residents should be encouraged to form a group for future maintenance.

Action: The Clerk to pursue the work being completed.

c) Information Boards – Canal and Kidsgrove Railway Station

The Clerk informed that herself and Cllr M Maxfield are not currently pursuing this.

d) Noticeboards

The Clerk informed that the report is still being compiled but this is not currently considered a high priority.

e) Provision of two Bus Shelters

It was reported that Staffordshire County Council have changed their position and no longer take funding from Town and Parish Councils but will still assist in getting quotes. The Parish or Town Council must remain responsible for the bus stops going forward.

It was noted that is responsibility will remain with the Town Council, the bus stops need to be as maintenance free as possible.

Cllr Robinson and the Clerk agreed to progress a report on this item.

To receive and consider an update report and draft plan of action for the Town Council's CCTV provision program.

The Clerk updated the Committee. The police have provided their priority locations. The Stoke-on-Trent monitoring centre is currently working on the technical aspects of the sites provided and a report will be compiled. Some of the suggested sites will require redeployable cameras. Fixed cameras will require the data to be relayed through the Town Hall and NULBC have agreed that their line can be used to transfer the data to the Stoke centre. The Clerk highlighted that extensive policy and documentation is required that will take extensive time.

The Committee **resolved** to recommend to Full Council that the project be delegated to the PIH Committee subject to remaining within budget (capital and revenue) plus no more than 20%.

Community Speedwatch: To receive an update on the provision of Community Speed Watch signs and to agree any recommendations/actions.

The Clerk has communicated with Safer Roads Staffordshire who have asked for information on the current location of community Speedwatch signs in relation to approved sites. The Clerk has offered to help with this. Until such time as the locations are approved, the Council cannot progress with the purchase.

Information has also been forwarded regarding setting up a group in Talke and Butt Lane.

Communication has been received that Community Speedwatch has currently been put on hold by Safer Roads Staffordshire until Covid-19 restrictions are eased.

Cllr Jukes confirmed that operations are on hold.

Speed Indicator Devices

a) To receive an update report and to consider and propose key siting locations in the Parish subject to approval by Staffordshire County Council. To consider and discuss a plan of action.

Cllr Jukes highlighted the need to purchase the items in such a way that the different aspects are co-ordinated and poles are purchased with clips.

The clerk informed that the police feel that locations for SIDS need careful consideration without over-populating and agreed to forward their thoughts on this based on statistics. Staffordshire County Council have affirmed that locations should be a Council decision, carefully considered.

Cllr Waring suggested a system of moving around SIDS, but the volunteer resource to do this also needs considering. Cllr Robinson agreed with Cllr Waring and also that the quantity of signage should be considered and there should be consultation. Cllr Jukes confirmed that the Community Speedwatch team are not willing to move SID devices around.

The committee affirmed their support for the project. Cllrs were asked to bring back locations where they receive complaints of speeding.

It was agreed that focus should be on the community speed watch signage.

b) To receive quotes and consider the purchase of a mobile SID for use in Kidsgrove Parish by the PSCOs.

The Clerk informed that she is going to requote for this device.
